### 1. Subject and purpose of this Agreement

Gold sponsoring of the 16<sup>th</sup> International Modelica and FMI Conference. This Agreement governs the cooperation between the Sponsor and HSLU regarding the 16<sup>th</sup> International Modelica and FMI Conference from 8-10 of September 2025 at the HSLU Campus in Rotkreuz.

The Sponsor agrees to support the 16<sup>th</sup> International Modelica and FMI Conference with a financial contribution described in clause 2 below. The contributions by HSLU are described in clause 3.

The conclusion of this Agreement does not affect the freedom of HSLU in teaching and research or its independence.

## 2. Contributions by the Sponsor

The Sponsor shall pay HSLU a sponsorship contribution of CHF 10 000 (ten thousand Swiss francs) (excl. VAT). HSLU will invoice the total amount after this Agreement has been signed. The total amount is due for payment 30 days after billing.

### 3. Contributions by HSLU

- a) The sponsor's logo will appear in the printed program and on the website. Size and placement depend on the sponsorship option.
- b) A reserved time slot for a Vendor Presentation is included. The Conference Board reviews presentations to ensure their content aligns with Modelica, FMI, and related standards (Tools, libraries, IDEs, etc. that support and foster these standards).

- c) An exhibition space of 10–12 m² is provided. Including 1 table, 2 chairs, power supply, and Wi-Fi. Reservation or on-site allocation depends on the sponsorship category or follows the "first come, first served" principle.
- d) Includes 2 standard registrations for the conference (dinner included).
- e) Includes a ½-page Sponsor Presentation in the conference program. The content is provided by the sponsor in a ready-to-print format and styling.
- f) HSLU will distribute a giveaway provided by the sponsor at the start of the conference.

### 4. Communication and Freedom of Information

The Sponsor acknowledges that HSLU is obliged under its legal requirements (Regulations governing the Fundraising at Lucerne University of Applied Sciences and Arts [Reglement zum Fundraising der Hochschule Luzern, FH Zentralschweiz] of 3 April 2014, SRL No 520f) to grant access to this Agreement to any person upon request. The Regulations governing the Fundraising at Lucerne University of Applied Sciences and Arts in Annex 1 form an integral part of this Agreement.

### 5. Term of the Agreement

This Agreement shall enter into force on the date of the last party's signature. It shall be concluded for a limited term and ends without notice on 11 September 2025.

### 6. Miscellaneous

No modification of or amendment to this Agreement shall be valid unless made in writing and signed by both Parties.

Shall any provision of this Agreement be invalid or subsequently become invalid, such invalidity shall not affect the validity of the remaining provisions or the Agreement in whole. Instead of the invalid provision, an appropriate provision shall apply, which approximates as closely to the aim and purpose of this Agreement as is permitted by law. The same shall apply in case of a contractual gap.

This Agreement is governed by Swiss law. The place of jurisdiction shall be the competent courts of the city of Lucerne, Switzerland.
